

Join Together—Join HCCMCA

The Health Care Cost Management Corporation of Alaska, Inc. (HCCMCA) negotiates cost savings with hospitals, physician and provider groups, prescription drug managers and other service providers for the benefit of its member health plans. By joining together, health plans gain power to negotiate better coverage and better prices from service providers. This allows health plans to lower health care costs for their own plan participants.

HCCMCA provides competitive benefit options for over 25 health plans in Alaska and 16 in the Pacific Northwest, ranging from 150 to more than 22,000 employees and dependents. HCCMCA members represent various types of plans, including Taft-Hartley Trust Funds, government health plans, public sector trusts and single employer plans.

HCCMCA provides a wide range of programs and services, from hospital and vision care PPOs to physical therapy services, from health fairs to prescription drug purchasing arrangements and more. Members may use all or just a few of HCCMCA's services, taking advantage of those programs that best fit their needs.

HCCMCA also helps research new programs and addresses service issues, reducing administrative costs.

HCCMCA continuously works with well-known service providers to develop and add service options. HCCMCA also participates in a 'Coalition of Coalitions' to take advantage of programs negotiated by other groups.

RUN BY AND FOR MEMBERS

HCCMCA, formed in 1994 by health plan representatives and industry professionals interested in reducing health care costs, exists solely to benefit its member health plans.

Today, HCCMCA is operated by a Board of Directors comprised of two representatives from each participating health plan. This structure gives members more control and allows them to monitor HCCMCA's activities, as well as participate in and direct programs.

Membership FAQs

Q: How can a health plan join HCCMCA?

A: Plans sign an agreement with HCCMCA and pay an initial one-time fee of \$3 per employee. (This initial cost is often recovered in the first year, by active participation in the HCCMCA's programs.) New member plans then select two individuals to serve as voting members of HCCMCA's Board of Directors.

Q: Are there additional costs to participate in programs?

A: Yes, HCCMCA charges an access fee for each program. Member plans complete a participation agreement, identifying the programs they want to use and then pay the access fee for each program. These fees fund the initial cost of new programs and pay for ongoing program costs. Member plans may also need to sign an agreement with the service provider(s).

Q: Are member plans required to adopt a particular schedule of benefits or use a designated administrator?

A: No. Each plan may continue to use its own plan design and administrator. Generally, few if any changes are required. Some provider contracts may require incentives for participants to use participating providers.

Q: Do member health plans have to participate in all of HCCMCA's programs?

A: No, each plan may choose the program(s) that best fit its particular needs.
